## EXHIBIT "B" OUT OF TOWN PARENTING SCHEDULE REVISED OCT. 03, 2011

If either party lives or moves out of state or outside a 200 mile radius of the other, the Non-Residential and/or Non-Custodial Parent shall have the following parenting time:

- A. From one week after school recesses for the summer to one week before school begins in the fall. This shall include the 4<sup>th</sup> of July, unless this is during the two-week parenting time of the custodial parent. The Custodial Parent shall be entitled to two full weeks of parenting time during this period which may be taken consecutively or non-consecutively, and shall notify the other parent regarding the dates of said parenting time on or before the date that school is released.
- B. Holidays: In the <u>odd-numbered years</u>, **non-custodial/non- residential parent** shall have:
- (1) spring break holidays from 12:00 noon on Saturday after school is recessed until 6:00 p.m. on Sunday before school resumes;
- (2) the weekend including the Memorial Day holiday and the Labor Day holiday, from Friday after school recesses until Monday at 6:00 p.m.;
- (3) on the day school is dismissed for the Christmas vacation to 2:00 p.m. on Christmas Day.

In even-numbered years, the **non-custodial/non-residential parent** shall have:

- (1) fall break holidays (if there is a fall break) from the afternoon school recesses until 6:00 p.m. on Sunday before school resumes;
- (2) Easter weekend, from Thursday after school recesses until Monday at 6:00 p.m.;

- (3) Thanksgiving weekend, from Wednesday after school recesses until Sunday at 6:00 p.m.;
- (4) Christmas Day at 2:00 p.m. until January 1st at 2:00 p.m.

The **custodial/residential parent** shall have all other holidays and times not addressed above, unless otherwise agreed upon by the parties.

- C. Any other reasonable time the Non-Residential/Non-Custodial Parent is in the town in which the minor child(ren) reside. The Non-Residential/Non-Custodial Parent shall give 48 hours advance notice and the visit should be no longer than 48 hours in duration unless otherwise agreed by the parties.
- D. Expenses of travel shall be borne: ( ) by the party that lives outside of Baldwin County; ( ) by the party that resides in Baldwin County; ( ) by both parties equally; ( ) each party to bear their own costs of travel, as the parties shall meet at a midpoint for exchange of the child(ren), to-wit:\_\_\_\_\_\_\_\_.
- E. The Non-Custodial Parent shall have access to all medical, school, and/or other official records or documentation, including report cards, and other documents relating to health, education and welfare of the children. The Non-Custodial Parent shall have the right to discuss the child(ren)'s medical conditions with the child(ren)'s doctors and shall have the right to participate in school activities of the child(ren), and to discuss the child(ren)'s progress in school with the child(ren)'s teachers. Each parent shall keep the other informed as to any significant illness or injury sustained by the child(ren), and shall notify the other as soon as possible if any child is admitted to the hospital, receives emergency treatment, or is scheduled for surgery. Each parent shall be kept reasonably

informed as to the location of the child(ren), including plans for extended trips outside of the State.

- F. The child(ren) shall be kept generally available for teleconference communication at all reasonable times, in particular, on special occasions, such as birthdays.
- G. Recognizing that conflict between parents is detrimental to the child(ren), each parent shall support and encourage the relationship of the other parent with the child(ren). Neither parent shall criticize the other nor undercut or call into question the parental authority of the other. Each parent shall use his or her best efforts to support and coordinate mutual policies on discipline, personal habits, and other matters involving the child(ren). Each parent shall insure to the fullest extent possible that his or her home environment provides a consistent and healthy site for raising the child(ren).
- H. Neither parent shall allow any person of the opposite sex, to whom he or she is not married or related by blood or marriage, to remain overnight or past midnight in his or her residence or other place where he/she may be staying, when the minor child(ren)are present.
